TERMS AND CONDITIONS

This Agreement is made on ENTER DATE HERE between GreenFree Ltd. (the Promoter) and the golf club named above, acting either as a limited company or through its Members' Executive Committee (the Golf Venue).

Whereas:-

- A:** The Promoter agrees to publish editorial to promote the Golf Venue in the GreenFree Course Directory listed on the GreenFree Website and via Emails where applicable.
- B:** The Promoter will at its discretion, seek out other marketing and promotional opportunities that it considers appropriate to reach significant numbers of golfers. From time to time, co-branded variations of the GreenFree website may be produced under licence by authorised marketing partners.
- C:** All promotion through these publications will be carried out FREE OF CHARGE to the Golf Venue.
- D:** The Golf Venue agrees to golf bookings from the Promoter's customers on the terms specified above, provided that:
 - 1. **the tee time is available**
 - 2. **the member is in receipt of a valid GreenFree voucher**
 - 3. **the member adheres to published terms and conditions of use**
- E:** The Golf Venue hereby acknowledges that it permits a GreenFree customer to use its facilities at their own risk and accepts a customer as a visitor in accordance with the Golf Venue's normal rules, terms and conditions. No liability will attach to the Promoter for the introduction of a customer to the Golf Venue.
- F:** This Agreement shall have a binding effect on both parties and will continue for an initial term of 12 months from the date of the Agreement. Either Party may terminate this Agreement by giving the other party prior written notice of not less than 90 days, such notice not to expire before the end of the initial 12 month period.

The promoter will then withdraw the Golf Venue from the website within 4 weeks of such written notice. For the avoidance of doubt, the Golf Venue must continue to honour the obligations assumed under this Agreement for the duration of this Agreement and during the 90 days Termination notice period.
- G:** The Golf Venue may request amendments to their webpage content at any time. Such amendments should be sent in writing and these requests will be completed on the GreenFree website within 2 weeks of receipt.
- H:** It is the responsibility of the golf venue to inform GreenFree of any changes to contact details and course information.
